Ernesto Cassetta is Associate Professor of Applied Economics (SECS-P/06) at the Department of Economics and Statistics (DIES) of the University of Udine, where he teaches Industrial Economics and Macroeconomics. Previously, from November 2008, he was a researcher at the same department. Since the 2008/09 academic year, he has been lecturer at the Luiss Guido Carli University in Rome, where he currently teaches Industrial Economics. He is also a lecturer in transport and energy economics at the Luiss Business School in the Executive MBA program in Circular Economy Management. He graduated with honors in Economics and Business from the LUISS Guido Carli University of Rome in 2001 and, afterward, he obtained a PhD in Law and Economics from the same university in 2005. He also obtained *cum laude* an LL.M. in Competition Law and Economics at the Rotterdam Institute on Law and Economics (R.I.L.E.) of the Erasmus University Rotterdam. In 2022, he obtained the National Scientific Qualification (ASN) for the role of Full Professor (in the field of Applied Economics - SC 13/A4). Since 2001 he has collaborated in the research activities of the Industrial and Financial Research Group - GRIF Fabio Gobbo of the Luiss Guido Carli University of Rome on the following topics: economics and industrial policy, regulation and antitrust, sector analysis and business management. He is a member of the Observatory for Sustainable Development and Renewable Energy (OSSER), set up at GRIF Fabio Gobbo. His research interests mainly concern economics and industrial policy, regulation and antitrust, energy and environmental policies, infrastructural policies, and transport economics. He has also achieved specific skills through studies and consultancy for companies and trade associations operating, among others, in the markets of electricity and natural gas, power generation from RES, local public transport, highways, pharmaceutical products, non-ferrous metals and aluminum, entertainment machines, paper recycling. Ernesto Cassetta was an economic consultant to the State Secretary to EU Policies of the Italian Government Presidency of the Council of Ministers. He was also in-house consultant for the Center for European Policy Studies (CEPS) in Brussels and testifying expert for the GSE and the Ministries of Economic Development and the

Environment on the solar PV incentive scheme at the Arbitration Institute of the Stockholm Chamber of Commerce (SCC) and the International Center for Settlement of Investment Disputes (ICSID). Ernesto Cassetta is a member of the SIEPI (Società Italiana di Economia e Politica Industriale) and coordinator of the Editorial Office of "L'industria. Review of Industrial Economics and Policy", edited by Il Mulino. He is the author of numerous publications in national and international journals, book chapters, books and research reports.
